



SG Loan

Salient Features

- **Historical Data** – Review historical position summary data by security and counterparty.
- **User-Friendly Interface** – Easy to use navigation system with professional user interface screens.




SG Locate

A RegSHO Compliance system

SG Locate is an SEC RegSHO compliance system that helps security industry firms stay in compliance with RegSHO requirements by *locating*, *effecting a borrow*, and recording a short sale and locate transactions with counterparty contact information.

Salient Features

- **Real-time communication** – Provides real-time communication between trading and stock loan teams.
- **Short Sale Request** – Allows trading user to input short sale security request. Receives automatic notification when security is located.
- **Locate Stock** – Alerts stock loan user with threshold security name, quantity, and firm short quantity. Automatically locates stock from easy loans list.
- **Integrates with internal systems** to include firm's short positions and easy loans in *threshold* securities.
- **Records and maintains transaction history** between Trading and Stock Loan.
- **Provides lenders contact information** to *locate* or *effect borrow* securities.
- **Low cost solution** and easy to maintain windows based application





SG Credit

A Counterparty Management and Credit Risk system.

SG Credit is a Credit Risk Management System for securities lending credit departments, offering counterparty management, automatic credit line allocation, credit exposure calculations, agency lending, and reporting.

Salient Features

- **Counterparty Management** – Manage Accounts, Addresses, Contacts and Financial Details of all Counterparties credit departments. Add / Edit and Delete Counterparty details.
- **Credit Line Allocation** – Allocate credit lines based on financial information of counterparty. Set maximum and minimum credit lines for a specified period.
- **Position Analysis** – Real-time position analysis by counterparty in different accounts – View variances, filter positions with high variance and credit violations.
- **Credit Risk** – Calculates real-time market variance with each counterparty and firm as a whole. Alerts traders and credit departments of any credit violations and exposures.
- **Historical Data** – Review historical credit lines, positions and exposures with each counterparty and adjust the rules to set new credit lines.
- **Agency Lending** – Manage principal lenders under different Agents. Approve/ Reject Principals based on financial data. Set customized credit lines at principal lender level. Generate various financial reports by principal lender.
